- Review to ensure we are on course with Current Year's:
  - LAND Trust Plan
  - Data
    - Reviewed school goals.
    - Looked at State Reports from the last two years for Reading, Math and Science and Acadience Reports for the current year.
    - Attendance percentage of attending regularly has increased.
    - School wide focus with faculty is focused on:
      - Clarity, DOK (Depth of Knowledge)/Rigor, OTR (Opportunities to Respond)/Engagement, & Feedback
  - Expenditures
    - Looked at the budget.
    - Extra dollars ½ day professional development with Building Leadership
      Team
- Begin Final Report for previous year's plan- Due end of January
  - Reading Goal: 62% K-5 made typical or greater growth (70% was goal)
    - Overall the school increased the percentage of students who met or exceeded expected growth from the previous yeast by 2%.
  - Math Goal: 80% of students making typical or higher growth. Results: K=71%, 1=69%, 2=84%, 3=70%, 4=84%, 5=68%)
    - This year the goal was not met. Three of six grades increased the percentage of students who met proficiency by 20% or more.
  - Money spent according to plan.
  - Office Discipline Referrals: We did not meet our goal of decreasing referrals.
    When outliers are taken out of the overall percentage, the number of office referrals did decrease.

- Review Attendance Plan
  - Attendance Goal: All students will attend school at least 95% of the school year.
  - The plan outlines valid excused absences and procedures for education/vacation leave.
  - Standard Notifications outlined for absences
  - Incentives are in place to celebrate attendance
- Additional school climate updates or principal Report
  - SAFE UT logo changed. Asked for update within district
  - Bus Routes -
    - Risk Management looked at areas of concerns and said everything looked fine
    - Transportation and Leon drove the routes and foresee some concerns.
      - Option 1 Could consider driving the route backwards because the bike lane is wider and removes fence barriers. Could also pull in Cottonwood Heights PD to train kids on safety.
      - Option 2 Leave the route the same way and move the stop to a different street.
      - SCC's considering option 2 leave the route the same and move the stop to the next street.
      - \*\* if possible asking SCC members to drive the route and see what option makes the most sense for the safety of the students.
